- STEP 1** Read and understand all steps in the instructions before starting the installation. Park the motorcycle on a hard, level surface and turn off the ignition. Let motorcycle cool.
- STEP 2** Use a small screwdriver or pick tool to remove the OEM spiral spring retainer from the pin. BE PATIENT! Lift the leading edge of the retainer out of the groove in the pin. Slide the retainer off the pin; it will “unwind” as it is removed. Discard the retainers, they will not be reused.
- STEP 3** Remove the pins from the mounts; remove the existing pegs; save the pins.
- STEP 4** Refer to PIC 2. Loosely install the footrest, sold separately, on the Adapter. The Adapters are NOT side specific.
- Note: The footrest does not need to be fully installed right now, but by installing it to the adapter it will help create ease of installation for the adapter itself.*
- STEP 5** Refer to PIC 2 and 3. Slide the footrest assembly into the mount; align the holes and secure with the existing pin. If the assembly has a loose fit, install the included “D” washer in between the mount and Adapter.

STEP 6 Refer to PIC 4. Secure the pin with the included Snap Ring; ensure that the Ring fully seats in the groove; it should spin freely when installed correctly.

STEP 7 Repeat STEPS 4 through 6 for the other side.

STEP 8 Adjust and finish installation for the Kuryakyn footpegs or floorboards that require a Splined adapter as per the instructions with the footpegs or floorboards.
